Dear Ms. McDaniel,

On July 14, 2023, I officially filed my candidacy for President of the United States. A copy of my Statement of Organization is included with this letter. On the evening of the same date, I had my kick-off rally with over a hundred people in attendance at the Downtown Richmond Marriott in Richmond, Virginia.

However, since that time, the Republican National Committee (“RNC”) has refused to acknowledge me as a legitimate candidate. Your roster of “Declared Republican Candidates” is not only false and misleading, but discriminatory.

My Republican bonafides are without question. I have been a Republican since approximately 1982. I have been an active participant in Republican politics ever since. I won the Republican nomination for Lt. Governor of Virginia in 2013, and ran for U.S. Senate. I have a nationwide support base among evangelical Christians. I was a radio talk show host for American Family Radio for at least five years, reaching millions of conservatives on 190 radio stations across America. I am indeed a legitimate “declared” Republican candidate for the presidential nomination.

I am forced to speculate whether you have chosen to exclude me because I am the only candidate in the race representing a Biblical Worldview. However, my views are consistent with the Republican Platform and the majority of the American people. The Republican Platform is pro-life, affirms traditional marriage and adheres to the Constitution. I took an oath to that Constitution as a United States Marine, and that oath will never expire.

Based on what I have seen and heard of the other candidates, I am the most conservative among them. My views represent Republican grassroots voters who are more committed to principle than party. They have a right to hear from a candidate who speaks for them. The RNC has no right to exclude me as a “Declared Republican Candidate.” The Constitution sets the eligibility requirements for President, and the people decide who is elected. By boycotting my candidacy, you are robbing the American people of their right to consider all options and make an informed decision.

Therefore, I am hereby making a demand that every RNC acknowledgment or announcement of the “Declared Republican Presidential Candidates” include my name and picture with the others. Please respond within five business days of receipt of this letter or we will take legal action to force you to show cause in a court of law why you are acting in an arbitrary, capricious and discriminatory manner.

When you communicate explicitly or implicitly that E.W. Jackson is not a Declared Republican Candidate, that is fraud and election interference with the right of the people to vote. It is the pre-election equivalent of arbitrarily refusing to put a candidate’s name on the ballot.
